# Adoption of the Agenda MOTION:

## President's Report (Attachment 1)

## Student Success Speaker

Sam Hardy, ASG President, is now a Certified Pharmacy Technician. Before coming to CPTC, she took culinary and psychology classes at other colleges. Since she was young, Sam thought about a career in pharmacy. She chose CPTC when visiting various school websites, because

CPTC had a shorter program and she could obtain an associate degree along with a certificate. Ms. Hardy attributes her success to faculty, advisors, and staff at CPTC. Her next step is to take Biochemistry at WSU, as she wants to be a pharmacy scientist to make healthier and less expensive medicine.

President Loveday's report also included these topics: Legislative Update, Student and Staff Awards, Ability to Benefit Waiver for First 6 Credits, Graduation Ceremony, Extension of 2018-19 Operating Budget, and ctcLink. Details are listed in Attachment 1.

## **College Reports or Highlights**

ASG Report (Tab 2)

Ms. Hardy gave the attached report. Chair Withrow recognized Ms. Hardy for her role in keeping the College community, students, and Board of Trustees apprised of student-funded programs, initiatives, and ASG business. Chair Withrow then presented Ms. Hardy with a small token of appreciation from the Board and wished her well in the future.

## ASG S&A Budget Overview for 2019-20 (Tab 3)

Mr. Erwin-Svoboda presented the attached, proposed ASG S&A Budget. Questions followed. Trustee Lachney thinks subsidizing childcare costs for those who qualify is an exceptional use of funds to help break down barriers for students. Does that decrease the operating budget deficit for the Hayes Center? Mr. Clark said the deficit is running around \$100,000.

## Overview/Update on Institutional Research (IR) Office (Tab 4)

Ms. Dana gave an overview/update on Institutional Research. Questions and discussion followed.

- Trustee Taylor said sometimes the data is more quantitative versus qualitative. How will you measure the emotional quotient (EQ)? How are students feeling about being able to succeed at CPTC? How will you measure that data? Ms. Dana replied that is one of the reasons the National Acceptance of Student Experience (NASE) was used; it is a quick snapshot of how students are doing and what CPTC can do better. There are also focus groups working on the data. Trustee Taylor would like to see the information via a dashboard, broken down by ethnic groups.
- Trustee Lachney asked after the dashboard data collection aggregation is parsed out, how will it be embedded into decision making? Decision making works well when you have all the information. This is part of the toolbox. President Loveday responded that discussions are occurring about what to regularly monitor, assess, and measure. Ms. Dana's office is creating a scorecard that will be used to track the trends.
- Once the College has aggregated that data and done some type of decision making, he suggested that future boards understand the methodology used and that it creates some validity to the numbers.
- In regards to the dashboards, how does it fit with the commonality of SBCTC and other colleges? Are they going to be using the same type of dashboards, and will colleges be able to communicate via ctcLink? Ms. Dana said the majority of community and technical colleges (CTCs) use Tableau. The SBCTC also allows colleges to house information on its server, and CPTC would have the ability to pull up the SBCTC dashboards to check for differences between their CPTC numbers and CPTC's numbers.

• Trustee Lachney suggested a publication of the lexicon that CPTC is using, as there is value in understanding the vocabulary.

## Chair's Report

Trustee Martinez reported that he attended the 2019 Washington State Association of College Trustees (ACT) Spring Conference in Walla Walla. The conference had informative sessions and the hosts were gracious. He attended a tour of their winery – the students plant the grapes, harvest them, and then produce wine. Kristy Snow, SBCTC, gave a ctcLink Update, and Trustee Martinez is now hopeful about the project.

Trustee Martinez thanked everyone who wrote or visited legislators this session, as higher education fared well with this budget. It was a team effort with a unified message from the CTCs.
