This letter serves as formal notification and official record of action taken by the Northwest Commission on Colleges and Universities (NWCCU) at its meeting on January 18-20, 2022, concerning the Fall 2021 Evaluation of Institutional Effectiveness of Clover Park Technical College. This action was taken after consideration of evidence, including the institution's Self-Evaluation Report, the Peer-Evaluation Report, the optional Institutional Response to the Peer-Evaluation Report, and information received as part of the institutional representative meeting with Commissioners.

Commendations

The Commission commends Clover Park Technical College for:

- Its Board of Trustees, active engagement, intentional leadership, and commitment to equity, their students, employees and local community.
- Its commitment to equity, diversity and inclusion, as evidenced by creation of a new Associate Vice President for Equity, use of equity gap data to address foundational curriculum, infusion of equity through its five college councils, and other activities identified throughout the visit.
- The rapid response to COVID, in particular with the College, attention to providing in person and remote wrap-around support services, including not limited to the Library, eLearning Lab, Tutoring, Student Life, Chat Box, as well as modifications to facilities and technologies in support of students.
- Its support for professional development and trainings, as evidenced by its new employee onboarding processes, faculty assessment day, annual professional development plans, and opportunities during off-contract periods, among other activities.

Recommendations Substantially in Compliance but in Need of Improvement

The Commission recommends that Clover Park Technical College:

 collaborative planning and budgeting activities to share and utilize meaningful goals, objectives,
 and indicators of mission fulfillment. (2020 Standard(s) 1.B.2)
- Recommendation 2: Fall 2021 Evaluation of Institutional Effectiveness Continue work to develop an effective system to assess program-level learning outcomes across all academic programs. (2020 Standard(s) 1.C.5)

Per <u>USDE guidance</u>, all virtual accreditation site visits shall be followed by in-person campus visits within a reasonable time when public health conditions improve and are authorized by applicable law. Campus visits may be limited to focus on items identified in the Peer-Evaluation Report and may include fewer than all evaluation team members.
